## Employment Transition Center

After many months of planning, renovations, inspections and re-inspections, our new Employment Transition Center (ETC) opened its doors in January 2009. This program is located on the property of Sacred Heart parish in Groton and provides vocational training to special needs high school students and adults from throughout the region.

The site features a state-of-the art commercial kitchen, computer lab, life-skills room, and resource library. Through the use of this newly renovated building, we offer culinary arts training in the areas of safe food handling and kitchen equipment knowledge, including the use of a six burner gas stove and convection ovens.

In addition to culinary training, the center offers the tools necessary to acquire computer and office skills. Individuals are being trained to build custom resumes, acquire basic data entry skills, and will learn the techniques of internet research.

Our program remains committed to providing individuals with everyday life skills, including those focused on time management, cooking, budgeting, banking, grooming and hygiene. The Center's resource library will serve as a communal gathering space to foster a group learning environment. It remains our top priority to place individuals in community jobs that are of interest to them. It is our hope that this new center will provide these individuals with inspiration and skills for success in the workplace. The Arc also provides transportation and other supports as needed to this population.

# Arc's *Connect-Ability* Strategic Plan Has Been Approved!


Back in April 2008, The Arc of New London County was awarded one of ten *Connect-Ability* "infrastructure change" grants from the CT Department of Social Services' Bureau of Rehabilitation Services, and charged with developing a strategic plan to address employment and transportation issues for young adults in high school School-To-Work Transition programs. Eight months, 11 meetings and nearly nine hundred e-mails later, The Arc's local pilot initiative submitted its Strategic Plan to the state *Connect-Ability* program on December 15, 2008 and received approval to move into its implementation phase on January 30, 2009. With the approval The Arc's Strategic Plan the local pilot initiative, now called CONNECT-NLC, was created.

CONNECT-NLC is a volunteer collaborative made up of educators, state and private service providers, advocacy groups, employers and other civic partners working to remove employment barriers for young adults with disabilities transitioning from high school to the adult world. CONNECT-NLC will provide students, their families and school transition coordinators information and technical assistance on Best Practices in transition services, will encourage more schools throughout the region to join the Best Buddies program, will work toward creating "bridge" services between school and adult

services in advocacy and other areas, and will partner with adult service providers and local employers to find jobs for young women and men who are leaving school.

CONNECT-NLC is creating **the m-p/3 project**, a "mini-pilot" that will involve three students from three schools working with three service provider agencies to help them identify their vocational interests and then "connect" them to three employers.

**The m-p/3 project** is currently scheduled to run through 2009.

## **1671 Center Groton Road, Ledyard Open House**

For several years it has been the dream of our Agency to have a permanent site for our Respite Program. Since July 2005, we had been operating a respite home on the property of Uncas-on-Thames through the support of the Department of Developmental Services (DDS). Because this was a temporary arrangement and the site was not barrier free, we spent many months seeking a permanent site that would be available to all people who needed respite.

Perry Lorenz, President and CEO of A-Z Construction and his family became aware of our need and donated a beautiful home, which used to be their family home-stead, located on 3 acres of land in Ledyard for our use. With the help of the Corporation for Independent Living (CIL),

Advanced Improvements, the Dominion Foundation, Pfizer volunteers through the United Way Day of Caring, and many other supporters, this house was extensively renovated and brought up to current fire and safety code.

An Open House celebrating this milestone was held on the evening of February 3, 2009. In spite of the snowy weather, a large group of friends and supporters attended to admire this new home and to thank Perry Lorenz.

The home will provide some permanency to 4 young women and two separate respite bedrooms for people who live at home with their families who occasionally need a break in caring for their loved ones. Stop by and say hello when you are in the neighborhood!

## Summer Day Camp is Here!!!

After many months of planning, The Arc of New London County is pleased to announce, in addition to our regular 7 week residential camp program, a **Pilot Summer Day Camp Program at Camp Harkness** for children ages 8-21 who have developmental disabilities.

*The Connecticut Family Support Network – Southeast* identified a pressing need for school aged children who are not quite ready for an overnight camp experience but would like to participate in enjoying summer camp. At the same time, the camp will also offer families a valuable respite from their caretaking responsibilities when summer school is ended.

Operated by Jen Sullivan Hickey, our very capable Camp Director, and her staff, the day camp will offer activities focused on services to children on the autism

spectrum and children with intellectual disabilities, and will include games, crafts, and daily access to the beach. Breakfast and lunch will be provided daily.

The day camp will run August 9-14, starting Sunday, August 9<sup>th</sup>, with a meet-and-greet day for the families from 1 to 4 p.m. Day camp will be offered all that week from 8:00 a.m. through 5:00 p.m. On Friday, August 14<sup>th</sup>, the week will conclude with a Family Picnic and awards ceremony.
